END USER LICENSE AGREEMENT

This End User License Agreement (this "EULA") is a legal agreement between the person or entity accepting this EULA ("Licensee") and Factory Data Systems, LLC ("Licensor") for Licensor's IntelliTrack™ software product and related documentation.

By clicking "I Agree," installing, accessing, copying, or otherwise using the Software, Licensee agrees to be bound by this EULA. If an individual accepts this EULA on behalf of an entity, that individual represents that he or she has authority to bind that entity. If Licensee does not agree to this EULA, Licensee may not download, install, access, copy, or use the Software.

1. Definitions

A) "Software" means the object-code version of Licensor's IntelliTrack™ software, together with related components, configuration tools, scripts, templates, documentation, updates, patches, and other materials provided by Licensor. Software excludes source code unless source code is expressly provided under a separate written agreement signed by Licensor.

B) "Documentation" means user guides, technical documentation, release notes, and other written materials provided by Licensor for the Software.

C) "Order Form" means any quote, order form, statement of work, invoice, purchase document, or other written ordering document accepted by Licensor that identifies the Software, license scope, fees, authorized site, permitted instances, support, maintenance, or services.

D) "Licensee Data" means data, records, configurations, product information, production information, inventory information, traceability records, genealogy data, lot data, serial number data, barcode or RFID data, label data, report data, credentials, and other information provided by or on behalf of Licensee or processed through or in connection with the Software.

2. Grant of License

A) Scope of License

Subject to Licensee's payment of all applicable fees and compliance with this EULA and any applicable Order Form, Licensor grants Licensee a limited, non-exclusive, non-transferable, non-sublicensable license to install and use the Software solely for Licensee's internal business operations, only at the authorized site, on the authorized systems, and within the usage limits identified in the applicable Order Form.

B) Installation and Use

Licensee may install and use only the number of production instances of the Software expressly identified in the applicable Order Form. No backup, test, development, QA, staging, disaster recovery, failover, redundant, high-availability, cloned, virtualized, containerized, or other additional instance is permitted unless separately purchased and expressly authorized in the applicable Order Form.

C) No Implied Rights

All rights not expressly granted to Licensee are reserved by Licensor. No license or right is granted by implication, estoppel, exhaustion, or otherwise.

3. Order Forms; Fees; Payment

Fees, payment terms, license scope, authorized site, permitted instances, support, maintenance, professional services, and any additional options are as set forth in the applicable Order Form. Licensee shall pay all fees and applicable taxes in accordance with the applicable Order Form. If any Order Form conflicts with this EULA, the order of precedence in Section 22 applies.

4. Restrictions

Licensee shall not, and shall not permit any third party to:

- copy the Software except as expressly permitted by this EULA or an applicable Order Form;
- modify, adapt, translate, or create derivative works of the Software;
- reverse engineer, decompile, disassemble, or otherwise attempt to derive source code, underlying ideas, algorithms, file formats, or interfaces of the Software, except only to the extent such restriction is prohibited by applicable law;
- rent, lease, lend, sell, sublicense, distribute, host, outsource, provide as a managed service, or provide the Software as a service bureau or for the benefit of any third party;
- separate components of the Software for use on more than one system unless expressly authorized in an Order Form;
- remove, alter, or obscure any proprietary notices, labels, license keys, or technical restrictions;



- circumvent, disable, or interfere with any license management, security, usage-control, or technical protection feature;
- publish benchmark results or comparative analyses of the Software without Licensor's prior written consent; or
- use the Software to develop, support, or improve a competing product or service.

5. Ownership; Intellectual Property

The Software is licensed, not sold. Licensor and its licensors retain all right, title, and interest in and to the Software, Documentation, updates, modifications, enhancements, derivative works, and all related intellectual property rights. Licensee obtains only the limited license expressly granted in this EULA.

Licensor represents that, to its knowledge, it has sufficient rights to grant the license described in this EULA. Except as expressly stated in this EULA, Licensor does not grant any warranty, covenant, or indemnity regarding intellectual property rights.

IntelliTrack™ and the Factory Data Systems logo are trademarks of Factory Data Systems, LLC. This EULA grants Licensee no right, license, or interest in or to any Licensor trademark, service mark, trade name, logo, or product name. Licensee shall not register, adopt, or use any mark confusingly similar to a Licensor mark, and shall not use any Licensor mark without Licensor's prior written consent, except that Licensee may refer to the Software by its correct name in a factual, non-misleading manner.

6. Licensee Data

Licensee retains all right, title, and interest in and to Licensee Data. Licensor does not acquire ownership of Licensee Data by providing the Software or related services.

Licensee is responsible for the accuracy, legality, completeness, quality, retention, backup, and use of Licensee Data. Licensee is responsible for obtaining all rights and permissions necessary for Licensor to access or process Licensee Data when providing support, implementation, troubleshooting, or other services.

7. Security; Credentials; Backups

Licensee is responsible for securing its networks, systems, databases, credentials, accounts, service accounts, scanners, printers, endpoints, mobile devices, and environments in which the Software is installed or used. Licensee is responsible for maintaining current and tested backups of its systems and data.

Licensor is not responsible for unauthorized access, data loss, downtime, corruption, failed transactions, or system compromise arising from Licensee's environment,



credentials, configuration, third-party systems, network conditions, or failure to maintain backups.

8. Traceability Use; Validation; Compliance

Licensee is solely responsible for validating all Software configurations, identifiers, barcode or RFID inputs, scanner inputs, label formats, serial numbers, lot numbers, product genealogy, database mappings, reports, dashboards, integrations, workflows, outputs, and related traceability processes before production use and after any change to the Software, Licensee's systems, or Licensee's operating environment.

The Software is intended to support Licensee's traceability, quality, inventory, and operational processes, but it does not independently guarantee regulatory compliance, product quality, recall effectiveness, inventory accuracy, label accuracy, or suitability of Licensee's manufacturing, warehousing, distribution, or quality processes. Licensee is solely responsible for maintaining appropriate operational, quality, regulatory, security, and compliance controls.

Licensor does not warrant that the Software will prevent production errors, inventory errors, scanning errors, traceability gaps, data loss, mislabeling, incorrect database records, quality failures, recall events, regulatory non-compliance, or interruption of manufacturing, warehousing, or distribution operations.

9. Support; Maintenance; Updates

Licensor has no obligation to provide support, maintenance, updates, hosting, training, implementation, configuration, or professional services except as expressly stated in a separate written agreement, Order Form, support plan, or statement of work accepted by Licensor.

Any updates, upgrades, patches, enhancements, or new versions provided by Licensor are deemed part of the Software and are subject to this EULA unless accompanied by separate terms. Licensor is not obligated to provide any particular update, feature, fix, compatibility change, or continued support for any version.

10. Third-Party Components

The Software may include, interoperate with, or require third-party software, drivers, libraries, databases, operating systems, reporting tools, communication protocols, or open-source components. Such components may be subject to separate license terms. This EULA does not modify those separate terms.



11. Confidentiality

Each party may receive non-public information from the other party that is marked confidential or that reasonably should be understood to be confidential given the nature of the information and the circumstances of disclosure ("Confidential Information"). Each party shall protect the other party's Confidential Information using at least reasonable care and shall not disclose or use such Confidential Information except as necessary to perform under this EULA or an applicable Order Form.

Confidential Information does not include information that is or becomes publicly available without breach, was known without confidentiality restriction before disclosure, is independently developed without use of the disclosing party's Confidential Information, or is rightfully received from a third party without confidentiality restriction.

12. Compliance Verification

Upon reasonable notice, Licensor may request that Licensee certify in writing its compliance with the license scope, usage limits, and restrictions in this EULA and any applicable Order Form. If Licensor reasonably believes Licensee is using the Software outside the authorized scope, Licensee shall cooperate in good faith to verify compliance. Unauthorized use requires payment of applicable fees and may result in suspension or termination under this EULA.

13. Term; Termination

This EULA remains in effect for the term stated in the applicable Order Form, or if no term is stated, until terminated as provided herein.

Licensor may terminate this EULA if Licensee materially breaches this EULA or an applicable Order Form and fails to cure the breach within thirty (30) days after written notice. Licensor may suspend or terminate immediately for non-payment, unauthorized use, infringement risk, security risk, misuse of the Software, or breach of Sections 4, 5, or 11.

Upon termination or expiration, Licensee shall immediately stop using the Software and destroy or return all copies of the Software and Documentation in its possession or control, except to the extent retention is required by applicable law or expressly authorized in writing by Licensor.

Sections concerning ownership, restrictions, Licensee Data, confidentiality, payment obligations, warranty disclaimers, limitation of liability, governing law, notices, order of precedence, and any accrued rights shall survive termination or expiration.



14. Warranty Disclaimer

TO THE MAXIMUM EXTENT PERMITTED BY LAW, THE SOFTWARE AND DOCUMENTATION ARE PROVIDED "AS IS" AND "AS AVAILABLE." LICENSOR DISCLAIMS ALL WARRANTIES, WHETHER EXPRESS, IMPLIED, STATUTORY, OR OTHERWISE, INCLUDING ANY IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE, NON-INFRINGEMENT, ACCURACY, SECURITY, AVAILABILITY, ERROR-FREE OPERATION, AND UNINTERRUPTED OPERATION.

LICENSEE ACCEPTS ALL RISK ARISING FROM INSTALLATION, CONFIGURATION, INTEGRATION, ACCESS, USE, AND PERFORMANCE OF THE SOFTWARE.

15. Limitation of Liability

TO THE MAXIMUM EXTENT PERMITTED BY LAW, LICENSOR SHALL NOT BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL, EXEMPLARY, OR PUNITIVE DAMAGES, OR FOR LOST PROFITS, LOST REVENUE, LOST SAVINGS, LOSS OF DATA, LOSS OF GOODWILL, BUSINESS INTERRUPTION, PRODUCTION DOWNTIME, COST OF SUBSTITUTE SOFTWARE OR SERVICES, MISLABELING, TRACEABILITY GAPS, INVENTORY INACCURACY, RECALL-RELATED LOSSES, OR QUALITY-RELATED LOSSES, WHETHER ARISING IN CONTRACT, TORT, WARRANTY, STRICT LIABILITY, OR OTHERWISE, EVEN IF LICENSOR HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

TO THE MAXIMUM EXTENT PERMITTED BY LAW, LICENSOR'S AGGREGATE LIABILITY ARISING OUT OF OR RELATING TO THIS EULA, THE SOFTWARE, DOCUMENTATION, OR ANY ORDER FORM SHALL NOT EXCEED THE AMOUNTS ACTUALLY PAID BY LICENSEE TO LICENSOR FOR THE SOFTWARE DURING THE TWELVE (12) MONTHS PRECEDING THE EVENT GIVING RISE TO THE CLAIM. THE LIMITATIONS IN THIS SECTION APPLY REGARDLESS OF THE ESSENTIAL PURPOSE OF ANY LIMITED REMEDY.

16. Assignment

Licensee may not assign or transfer this EULA, any Order Form, or any rights or obligations under either document without Licensor's prior written consent, and any attempted assignment or transfer without such consent is void. Licensor may assign this EULA or any Order Form in connection with a merger, reorganization, sale of assets, sale of equity, or transfer of the Software or related business.

17. Governing Law; Venue

This EULA is governed by the laws of the State of New York, without regard to its conflict-of-law rules. The parties consent to exclusive jurisdiction and venue in the state and federal courts located in Monroe County, New York, for any dispute arising out of or relating to this

EULA. The prevailing party in any action to enforce this EULA is entitled to recover its reasonable costs and attorneys' fees.

18. Notices

Legal notices to Licensor must be sent to Factory Data Systems, LLC, Attn: IntelliTrack Support, 520 Lake Shore Dr, Hilton, NY 14468-9561, or to another address designated by Licensor in writing. Notices to Licensee may be sent to the address, email address, or contact listed in the applicable Order Form or account records.

19. Waiver

No failure or delay by either party in exercising any right under this EULA shall operate as a waiver of that right. Any waiver must be in writing and applies only to the specific instance identified in the waiver.

20. Severability

If any provision of this EULA is held invalid, illegal, or unenforceable, that provision shall be limited or eliminated to the minimum extent necessary, and the remaining provisions shall remain in full force and effect.

21. Entire Agreement

This EULA, together with any applicable Order Form, constitutes the entire agreement between Licensor and Licensee regarding the Software and supersedes all prior or contemporaneous understandings, representations, statements, conditions, warranties, or agreements regarding the subject matter of this EULA.

22. Order of Precedence

In the event of conflict among documents, the following order controls unless expressly stated otherwise in a signed writing by Licensor: (1) a signed master agreement between the parties; (2) the applicable Order Form or statement of work; (3) this EULA; and (4) Documentation.
